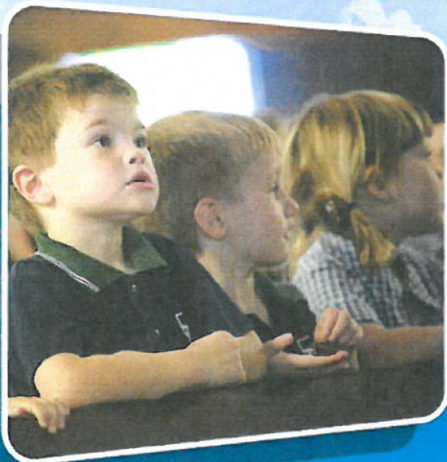


Why is the Catholic Special Character Contribution important?

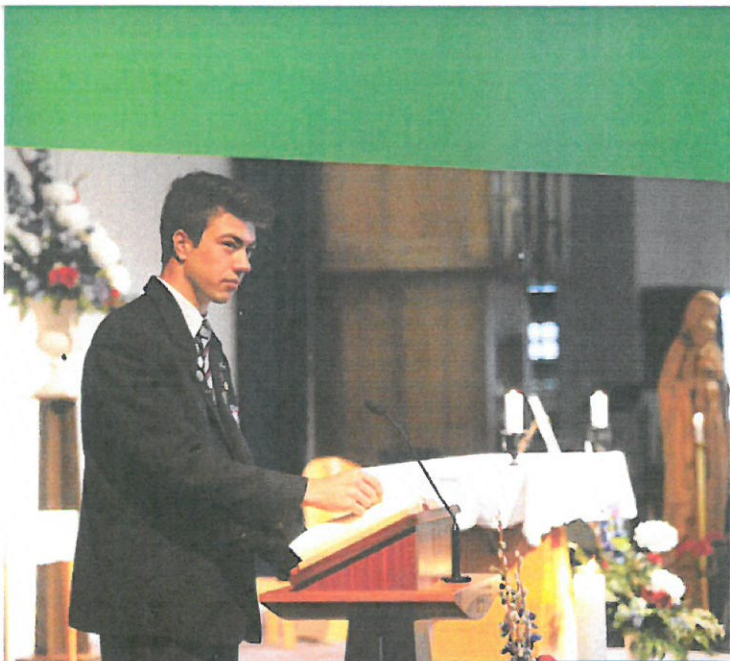

What is the Catholic Special Character Contribution?
